Re: COVID-19 Press Conference Update

As you are aware, Governor Inslee held a press conference yesterday, November 15th in which he laid out a number of new restrictions that will be in place until December 14th. I want to share with you the impact it will have on residents at TLRC. Therefore, beginning today:

- COVID TIMES weekly bulletin will return
- The indoor wellness center classes and pool are closed. Outdoor classes will continue (weather permitting) with no more than 4 residents plus 1 instructor at a time per class. Because of the size of Rainier Vista, we will be able to hold two classes at a time which will include social distancing and the wearing of masks.
- The Mortvedt and Art Center activities have been cancelled. We will move to at-home kits such as card making, beading and painting, etc.
- Outdoor visitation for Health Center and Assisted Living residents will continue in the current manner.
- The tree lighting ceremony scheduled for December 2nd will be observed from rooms. There cannot be any gatherings of more than 5 people and those must be outside.
- We will continue with deliveries of food and beverages for social events (celebrated individually). In observation of the holidays, we will have these occur each Friday through the end of the year.
- We will continue to take TLRC Apartment and Six-Plex residents to the grocery store per the current schedule. In addition, we will continue to observe

social distancing and reduced number of residents on TLRC buses as well as require the use of PPE.

- All social trips that involved interacting with people from the community have been cancelled. Trips such as viewing the Christmas Fantasy lights will still occur (reduced number of residents on the TLRC buses and wearing of PPE is required).
- Holiday shopping trips for Apartment Residents will continue as scheduled.
- The Harbor Café will not be available for any TLRC resident to dine in. Residents can order their food and pick it up in the café or have it delivered to their residence. The only people that can dine-in the Harbor Café are staff for their break times.
- We will need to cancel the Thanksgiving dinner that was scheduled for the Mortvedt Center. You may still order Thanksgiving dinner to be delivered to your residence.

While I recognize this may feel as though we are taking steps backward, I hope you realize these actions do **not** amount to a total lockdown or stay at home order. The steps noted in this memo are meant to keep you as safe as possible yet allow you to move about in a cautious manner. Please remember these steps are in effect only until December 14th. The TLRC team has worked hard to meet all your needs during the 9 months we have been dealing with the COVID-19 pandemic. They have been creative, dedicated and determined to help you live as normal of a life as possible. I am very proud of all our staff and know that they will continue their efforts to minimize the impact these new rules will have on your lives. While the phrase “Together We Will Get Through This” may be a bit overused, I believe TLRC has exemplified this since Day 1. We have always been together with our residents, families, friends, business partners and the overall community and appreciate the support we have received.
