

## **SUMMARY ANNUAL REPORT**

### **For Lutheran Services in the Northwest, LLC**

This is a summary of the annual report of the Lutheran Services in the Northwest, LLC, EIN 91-2130411, Plan No. 501, for period July 01, 2020 through June 30, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Ameritas Life Insurance Corp., Delta Dental Of Washington, First Choice Health, Kaiser Foundation Health Plan Of Washington, Kaiser Foundation Health Plan Of Washington Options, Inc., Prudential Insurance Company Of America and Willamette Dental Of Washington, Inc. to pay health, dental, vision, life insurance, long-term disability, prescription drug, HMO, PPO, Employee Assistance Plan and AD&D, Vol Life, Vol AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2021 were \$6,575,794.

Because Delta Dental Of Washington and Willamette Dental Of Washington, Inc. are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending June 30, 2021, the premiums paid under such "experience-rated" contracts were \$359,652 and the total of all benefit claims paid under these contracts during the plan year was \$305,052.
